

Statement of Financial Responsibility

By submitting this signed Statement of Financial Responsibility to Sea State (SS), I agree to the fee payment, refund schedule and financial responsibility policy outlined below.

- This policy applies to all cancellations, regardless of the reason
- Your request to withdraw and receive a refund must be made in writing to SS.
- Alternative payment arrangements (financial aid, scholarships, payment plans, etc.) do not exempt you from this policy

Sea State Deposit Fee

As a student applying to participate in a SS study abroad program I understand that I must pay my program deposit by the payment deadline for my program. I also understand that my place in the program is not secured until I have paid the deposit and that the program may fill before the deadline. Applications are reviewed and accepted on a rolling basis and all programs have a limited number of spaces.

Sea State Program Fee

I understand that I must pay a Program Fee as a condition of participation in the Program. I understand that I am expected to pay the designated Program Fee by the posted due date or I risk losing my acceptance to the program along with my program deposit fee.

Program cancellation

If the Program is cancelled for any reason, I understand that I will receive a full refund of all SS fees I have already paid. SS will not be responsible for, and I will not be entitled to compensation for, any personal expenses or losses incurred as a result of Program cancellation, including, but not limited to, airfare, passport and visa fees. SS strongly recommends that I purchase fully refundable airline tickets and/or trip cancellation insurance to safeguard against losses or penalties associated with my withdrawal from the Program or Program cancellation. I understand and agree that SS assumes no responsibility for such losses or penalties.

Additional Expenses

I understand that additional expenses including, but not limited to: round-trip airfare, medical expenses, damaged or lost baggage and gear, flight schedule changes, additional accommodation expenses, expenses related to weather conditions or natural disasters, personal expenses and incidentals are my sole responsibility and are not part of the Program Fee. SS requires International Travelers Insurance which includes travel / trip cancellation insurance to safeguard against losses. I understand and agree that SS assumes no responsibility for such losses.

Financial Aid and Scholarships

If I am a Financial Aid or Scholarship recipient, I acknowledge that it is my sole responsibility to make arrangements for these funds to apply to the SS fees outlined above by the specified deadlines.

Application & Program Deposit Deadline - Nov. 1st (\$800)

Final Program Payment - December 1st (Amounts vary per Program)

Spring Programs

Application & Program Deposit Deadline - January 15th (\$800)

Final Program Payment - February 15st (Amounts vary per Program)

Summer Programs

Application & Program Deposit Deadline - March 30 (\$800)

Final Program Payment - May 1 (Amounts vary per Program)

Sea State Fee Refund Schedule

Winter Programs

Withdrawal deadline for 75% refund eligibility - November 15th

Withdrawal deadline for 15% refund eligibility - December 1

No refunds will be issued after December 1

Spring Programs

Withdrawal deadline for 75% refund eligibility - February 1

Withdrawal deadline for 15% refund eligibility - March 1

No refunds will be issued after March 1

Summer Programs

Withdrawal deadline for 75% refund eligibility - April 15

Withdrawal deadline for 15% refund eligibility - May 1

No refunds will be issued after May 1
